Audit Findings

Audit Narrative

This report is for the Summit Academy in Herman, Pennsylvania. The facility is operated by the Academy Schools under licensure of the Pennsylvania Bureau of Human Services Licensing. The on-site portion of the audit took place August 13, 2018. It was the second Prison Rape Elimination Act (PREA) compliance audit for the facility.

The Summit Academy is a non-secure treatment program for court adjudicated male adolescents operated under licensure of the Pennsylvania Bureau of Human Services Licensing. The facility provided a list of all staff by shift and employee job categories and a list of all youth by housing unit. Prior to arrival this auditor reviewed pertinent agency policies, procedures, and related documentation used to demonstrate compliance with the Juvenile Facility PREA Standards. The pre-audit review of documents contained in the Pre-Audit Questionnaire submitted by the facility prompted few questions. Answers to those questions were submitted to this auditor by the facility staff and any additional remaining questions were resolved during the audit. This auditor interviewed 10 of the current 205 youth. The youth interviewed were a representative sample from each of the housing units. Length of stay for those interviewed ranged from two months to eleven months. There were no youth who identified themselves as lesbian, bisexual, gay, transgender or intersex and no youth identified by the facility as gender non-conforming in appearance. There were no youth who needed translation services. No youth had specifically requested to speak with this auditor nor had this auditor received any written correspondence from youth or staff (the audit notice was prominently posted on all housing units and common areas). There were no youth currently in the program who made an allegation of sexual abuse or sexual harassment at the program.

Auditor arrived at the Summit Academy the morning of August 13, 2018. An entrance meeting was held with the Executive Director, Program Director, and the Human Services Coordinator (who also serves as the PREA Coordinator).

A complete tour of the facility took approximately one hour. All areas were extremely well maintained. The Summit Academy has a video surveillance system which provides coverage for 50% of the facility. The system provides coverage of the both housing units and hallways. There are no cameras in the youths' rooms. Observed staffing (5 : 1), while this auditor was on site exceeds the standards requirement of 8: 1. One of the housing units for Summit Academy has multi-stall showers and toilets. which are appropriately partitioned for privacy and properly supervised when more than one youth is in the room. Youth are permitted to shower and use the bathroom alone if requested. This was confirmed by all staff and youth interviewed. Sight lines are

good in all housing areas (there are no unmitigated blind spots on the housing units). The second housing unit at Summit has individual bathrooms in the youths' rooms.

Youth were observed during recreation, in school, during movement, work details and at meals. Observations of staff supervision practices were consistent with the agencies policies.

The PREA screening for risk is conducted by Intake and clinical staff on the date of admission, and documented. All youth interviewed acknowledged being screened on the date of admission as well as being seen by medical staff within 24 hours of admission. In addition to the above, all youth are extensively screened prior to acceptance into the program. Youth with a history and/or adjudication of sexual acting out or sexually aggressive behaviors are not admitted to either program.

Administrative investigations regarding allegations of PREA violations are conducted by Butler County Office of Children, Youth and Families investigators. Criminal investigations of sexual abuse and assault are conducted by the Pennsylvania State Police. Forensic examinations and evidence collection are performed at the Butler Memorial Hospital.

Random direct-care staff were selected for interviews to include staff from all housing units and all areas of program. Experience levels ranged from eight years to 23 years. All presented as very knowledgeable about their jobs and highly dedicated to keeping youth safe. All staff members knew their obligations as mandated reporters and first responders. All felt well supported by facility management, and had no fear regarding retaliation for reporting abuse. All staff have received PREA specific training as first responders and all knew what to do if they were a first responder. All felt empowered to proactively address issues related to sexual violence and were able to describe actions they would take to prevent and/or deter potential and/or imminent threats of sexual violence.

A total of 10 (out of 205) youth at the facility were interviewed, and included youth from all housing units. Ages ranged from 16 to 18 years. There were no youth currently at the facility that had made an allegation of abuse that occurred at the facility. There were no youth currently at the facility who had reported an allegation of sexual harassment that occurred at the facility. There were no youth at the program who identified as LGBTI or had been identified as gender non-conforming in appearance. All youth acknowledged being asked about sexual orientation, history of sexual abuse and concerns about safety upon admission. All youth interviewed had extensive knowledge of the right to be free from sexual abuse, assault or harassment. All youth were aware of multiple methods for reporting abuse. All youth acknowledged being screened upon admission and receiving information upon admission on their right to be free from abuse in any form. All youth said they currently felt safe at the facility. Four out of 10 youth interviewed had been in other facilities. Three out of the four stated that this was the best program they had been at. The fourth stated that Summit Academy was a good program, but it was easier for him to get visits when he was in detention near his home.

The quality and organization of the documentation provided to this auditor was very good. The pre-audit questionnaire was submitted in a timely fashion. The referenced documents in the questionnaire were provided electronically.

Facility Characteristics

Located at 839 Herman Road in Butler County, Pennsylvania, The Summit Academy is a residential treatment program for male juvenile offenders who, upon admission are 14 to 18 years old; service will be continue to be provided to students at ages through the jurisdiction in the court. The Summit Academy is a non-profit, private service provider with specialized experience and skills in treating delinquent youth.

Campus facilities include 180,000 square feet of indoor building space situated on 122-acres. The campus is equipped with an academic building, college-style dormitory, library, auditorium, two gymnasiums, outdoor pool, recreational areas, and a spacious athletic field.

The Summit Academy has received national and statewide recognition for its programming and has been honored as the Pennsylvania Juvenile Court Judges' Commission "Residential Program of the Year".

The premise on which The Summit Academy is founded is that which guides the other programs operated by The Academy Schools. That is: "The only true growth is self-growth". The program is implemented in a completely therapeutic environment based on the Balanced Approach to Restorative Justice (BARJ).

The goal of The Summit Academy is to help students experience a process of self-growth, achievement and accomplishment, and apply those strategies on both a daily and long-term basis when they return to their own homes and communities.

Specific program objectives are:

1. To hold offenders accountable by removing them from the community and placing them in a well-structured, supervised setting.
2. To teach respect for self, authority, and community through the utilization of counseling techniques which aid in the identification of individual inappropriate and anti-social behavior.
3. To stress self-worth and self-discipline.

The students consistently participate in a structured schedule which includes a traditional school day of academic curricula, an evening program of counseling and trade-training, as well as a full spectrum of weekend activities and programming. Every student is assigned to a counselor who is responsible for the development, implementation, and evaluation of the student's Individualized Service Plan (ISP). New students begin mainstream activities after completion of 30-days in the Diagnostic Unit. Parents receive weekly communication regarding student progress, and Probation Officers are updated regularly. In addition, formal reports are forwarded to each student's Probation Officer and Judge throughout the course of the commitment. Home passes are recommended and approved in compliance with the Juvenile Court Judge's Home Pass Standards. Students who present a serious threat to abscond or violate program rules, which cause staff or other students to be at risk, are temporarily placed off-campus at The Academy Knights Unit.

The Summit Academy provides for all student clothing needs. During the school day, the uniform includes a blazer, oxford shirt, tie, khaki pants, and loafers; except in the summer months when the school uniform consists of khaki shorts and polo shirts. A clean, neat appearance is encouraged as well as personal grooming and hygiene. Closely cropped hair is mandatory.

The Summit Academy functions officially as an approved Private Secondary School licensed by the Pennsylvania Department of Education for grades 9 through 12. Upon admission, individual student assessments are completed to determine specific strengths and weaknesses, while grade placement is based upon prior academic history and standing. The school operates a year-round academic program to allow for maximum progress and academic matriculation. A curriculum is set up for each grade level, which includes English, Mathematics, Science, Social Studies, Health, Physical Education, Art & Humanities, Drug and Alcohol Education, and Career Development. All course assignments and variables that follow are accomplished on an individual need assessment in compliance with state graduation requirements.

The core subject areas of English, Math, Science, and Social Studies are each presented in the class schedule for five, forty-five minute periods per week. All students also participate in a daily, supplement, remedial classes in both math and English, designed to bridge the typical gap between their academic skills and their grade level. Elective courses are offered for two, forty-five minute periods per week. In addition, students have access to a full-standing library, computer lab, technical drawing class, and individual or small group tutoring sessions on a regular basis. Students entering Summit Academy with a previous Individualized Education Plan will be referred for services through our Special Education Department.

The Summit Academy is licensed to present qualified students with a state accredited high school diploma upon completion of their course requirements. All faculty members hold either a Pennsylvania Public Teaching Certificate or Private Academic Teaching Certificate.

GED preparatory classes are offered as an alternative for those students who are best suited to complete their high school requirements via this process while attending The Summit Academy. On-site examinations are administered regularly to those students demonstrating appropriate skill level. The primary focus of The Summit Academy's Industrial Trades Training Program is based on the self-growth, achievement and sense of accomplishment that are realized through the development of industrial trade skills.

The Summit Academy's Industrial Trades program teaches basic trade skills, instills a solid and positive work ethic, and paves the way to a means of self-sufficiency. Industrial Trades training is an excellent method for teaching a pro-social value system while building positive character traits in our young men.

Students are expected to complete at least two Industrial Trade curricula while attending The Summit Academy. Basic instruction is provided in Technical Drawing, Woodshop, Carpentry, Food Service, Building Maintenance, Automotive & Auto Body Repair, and Screen Printing.

Various on-site work programs are offered to students who have court-ordered restitution, including work within the Food Service, Building Maintenance, Laundry and Landscape Beautification Programs. Summit Academy also offers an extensive Community Service Program which includes various volunteer opportunities throughout the region. These efforts not only teach a sense of giving back to the community but also fulfill the court-ordered requirement to complete a minimum of 50 community-service hours.

The Summit Academy's Adolescent Inpatient, Non-Hospital, Residential Treatment Program, licensed by the Department of Health provides services to males who have been determined as having a medical necessity for substance abuse or addiction therapy.

In addition to the traditional counseling services offered at Summit Academy, certain students receive individualized counseling through our Specialized Behavioral Health Program (SBHP). In general, students in the SBHP receive individual counseling sessions from a masters-level mental health professional, as well as medication management provided by a psychiatrist as required.

The facility maintains 24 hour supervisory coverage as well as an on-call administrator.

The Academy Schools PREA Policy, page 4, requires unannounced rounds. This auditor was provided documentation of these rounds and interviews with supervisory staff confirmed that they occur. Observed staffing ratios of 5 : 1 during the on-site audit exceeded the standards during program hours. Over-night staffing in compliance with the standards was documented on staffing schedules, housing unit logs as well as interviews with staff and youth. There were no instances of deviations from the staffing plan due to training, vacations, Family Medical Leave and other types of leave. Overtime is paid to maintain staffing ratios.

The Academy Schools PREA Policy was reviewed by this auditor. The policy meets all the requirements of this standard. It requires that all allegations of sexual harassment and sexual abuse be investigated. It requires that allegations that may be criminal in nature be referred to law enforcement and provides clear guidance for when the facility may conduct an administrative investigation once a referral to law enforcement has been made. All staff are mandated reporters of abuse and all staff interviewed were aware of their obligations to report abuse under Pennsylvania law. The facility reported eight allegations of sexual harassment, sexual abuse or sexual assault during this audit period. Six allegations were referred to law enforcement for investigation. The Academy Schools policy requires reporting of sexual harassment allegations that do not rise to the level of sexual harassment as defined by the PREA standards (the standards specifically state "repeated" as a condition of the definition). While there were no allegations of sexual harassment that rose to the level of sexual harassment as defined by the PREA standards Summit Academy is intentionally reporting and investigating single occurrences of sexual harassment in order to improve the conditions of confinement at the facility as they relate to PREA compliance, and they should be applauded for their efforts. This practice clearly exceeds the requirements of this standard. Based upon all of the above this standard was deemed to exceed the standard.

This information is part of a larger education program known as "Child's Rights". Youth receive materials about PREA and their rights to be free from abuse upon admission. These documents are available in English and the agency has access to translation services for Spanish, or any other language they may encounter. The youth signs an acknowledgement that they understood the material presented. All youth interviewed were aware of the right to be free from abuse and multiple means of reporting allegations of abuse. Youth receive materials at admission regarding how to report abuse and there are posters throughout the facility and on all housing units with the information. All staff are mandated reporters of abuse per Pennsylvania regulations and The Academy Schools PREA Policy. All staff interviewed were aware of their obligations as mandated reporters.

The Academy Schools PREA policy complies in full with this standard (response time frames, appeals and acceptable grievance sources and formats). The Program Director reported there is a system in place to monitor for retaliation and documenting any actions taken in response.

Youth are extensively screened prior to admission/acceptance into the program. Youth admitted to Summit Academy are seen by medical staff within 24 hours of arrival. Staff performing the youth's intake utilize a screening tool to determine if a youth has any immediate and/or emergency medical or mental health needs. All youth interviewed confirmed that they were seen by medical staff shortly after arrival at the facility. Interview with medical staff confirmed that screening includes history of sexual abuse. Per medical staff interview, youth have access to all the same medical services available to youth in the community. When a disclosure of prior abuse occurs, and services are offered by Medical and/or Mental Health staff, this is documented in the youth's case file.

There were no incidents of sexual abuse or sexual assault necessitating on going services occurring at the facility during this audit period and therefore there was no documentation of practice to review. In the event that an incident was to occur the victim would receive services from the community provider. As previously noted, services from these providers are at no cost to the victim. All ongoing medical care beyond the scope of facility medical staff would be provided by community providers. The resident would have the option of facility clinical staff or community providers for ongoing mental health services.
